**EBRD Belarus Investment Conference showcasing the M-10 Highway Public-Private Partnership project & the Great Stone Industrial Park**

The European Bank for Reconstruction and Development (EBRD) in association with the Government of Belarus and the management of the Great Stone Industrial Park, Belarus are organising an investment conference on Wednesday, 16 January at EBRD Headquarters, One Exchange Square, EC2A 2JN, London UK. The event will focus on business and investment opportunities presented by the country's first ever Public-Private Partnership project (to fund the M-10 Highway) and the Great Stone Industrial Park to the international business community.

The event will be opened by EBRD President, Sir Suma Chakrabarti and will feature senior government representatives from Belarus including H.E. This event will be an excellent occasion to discuss the business environment in Belarus and to hear about technical aspects of the M-10 Highway Public-Private Partnership project and investment opportunities in the Great Stone Industrial Park, including through potential cooperation with the EBRD. All the presentations will be followed by Q&A sessions. In addition, should participants express interest, short one-to-one meetings will be organised with the authorities, Administration and the Development Company of the Great Stone Park and EBRD staff. Registration to the event is expected to start at 11 am on the day, and formal presentations and panel discussions to be completed by 4:30 pm, with one-to-one meetings continuing until 6 pm. Working languages of the event: English/Russian with simultaneous translation.
